# Alaska Air Group Credit Union

## 2026 Scholarship Award Program

Alaska Air Group Credit Union offers a scholarship fund for the benefit of its members and families. The purpose of the scholarship is to recognize and provide financial assistance to college or trade/technical school students pursuing an education in any degree program of study.

This scholarship award is subject to the following rules and regulations.

1. The candidate must be a member of Alaska Air Group Credit Union to be eligible to receive an award. Non-members may apply by proving eligibility through employment of Alaska Air Group, or through a family member (or member of household) that is a current employee or retiree with Alaska Air Group. However, applicants that are selected for an award must establish individual membership with Alaska Air Group Credit Union before receiving their awarded funds. Employees and family members of Alaska Air Group Credit Union and the Board of Directors are not eligible.
2. The candidate must be a senior attending high school or have achieved a high school diploma, and are encouraged to have maintained a 3.0 ("B") average over the last three quarters or two semesters they were in school.
3. The recipient must be enrolled to attend a college certified by a regional accreditation association, or a school recognized by the Accrediting Commission of Career Schools & Colleges of Technology (ACCSCCT). The recipient must provide proof of verified registration at an approved school in order to receive award funds.
4. The application must be on the official Alaska Air Group Credit Union application form and received by the credit union by April 6, 2026. Mailed applications received after the deadline but postmarked by the designated date will be accepted.
5. A committee appointed by the credit union's Board of Directors shall select awardees. Applications shall be modified to remove names and identifiers so a "blind" selection process may be made without influence. Application originality and personalization is encouraged and will be taken into consideration in the evaluation process.
6. The Board of Directors of Alaska Air Group Credit Union shall determine the number and amounts of awards. This year the Board of Directors approved a \$10,000 award amount to be distributed among the winners selected by the Scholarship Committee. The Board maintains discretion to adjust this amount. In addition, the Board has set an award minimum is \$500 per selected recipient.
7. A recipient is limited to one award per year, and two awards per lifetime. Scholarships are awarded one time only and are not renewable.
8. If selected as a recipient, payment of the award shall be made directly to recipient upon submission of the following items:
  - a) Verified acceptance and registration at approved school.
  - b) Photo of recipient, approved blog excerpt, and affiliation to Alaska Air Group.
  - c) Confirmed mailing address.
  - d) If not already an AAGCU member, membership must be established.

Recipient must submit these items within three weeks of the date they are notified of selection. Delays may result in forfeiture of the scholarship award.

Explain how these activities have been important in your life, and any impact of your contributions.

2. **Contributions to Community** - Describe your community activities and contributions including estimated hours volunteered and any recognition you may have received for your non-school or professional related activities. Explain any impact or world experience gained through these activities, and why they were meaningful to you.  
*Between 200-350 words.*
3. **Educational Goals** - Describe your educational goals and motivations. This can include your career aspirations, reason for selecting your field of study, and steps you intend to take to achieve these goals.  
*Between 200 - 350 words.*
4. **Credit Union Question** - This scholarship is provided by Alaska Air Group Credit Union. One of the key components of the credit union difference is helping encourage the financial wellness of our members. What does financial wellness mean or look like to you and how does financial wellness play a role in your daily life?  
*Between 150-250 words.*
5. **Personal Statement** - Please attach a personal statement to allow the Scholarship Committee to know and understand you better as a person. This statement should include why you would be a good candidate to receive the scholarship and any other relevant information you would like the Scholarship Committee to know.  
*Between 500-750 words.*
6. **School Transcripts** - Please attach a complete transcript of grades and credits. Applicants are encouraged to have maintained a 3.0 (“B”) average over the last three quarters or two semesters. Difficulty of classes taken will be considered as well as the grade received. If your school does not utilize a standard grading system (i.e., flight school), please provide an additional document explaining.
